Create a simple Photoshop file For this article, I'll be using a very simple photography file that I created using Photoshop Elements. It's an image of a candle holder with a vase of tulips. I first composed the background and then created the simple candle holder. Create a new document in Photoshop Elements using the following settings: Resolution – 72 pixels Skew – Horizontal – 30° Allow placement of elements – Turn this off I changed the document background to a pale color using the Paint Bucket tool (Command + R). I opened the document in Photoshop, and I added the candle holder using the following steps: Create a new layer. I made sure that it was a duplicate layer (Command + J) Use the Ellipse tool to draw the top center of the candle. Use the rectangle tool to enlarge the rectangle so that it just covers the candle. Use the Direct Selection tool (Command + A) to grab a rectangle around the candle. Use the Move tool (Command + V) to move the candle up and left a little so that the candle fills the space. Use the Direct Selection tool (Command + A) again to select the top-left part of the candle holder. Use the Move tool (Command + V) to move the candle down and right a little so that it fills the space. Use the Move tool (Command + V) to move the candle holder down and slightly right so that it is aligned with the top of the candle. Make sure that all your layers are visible (F5) Create a new layer. I made sure that it was a duplicate layer (Command + J) Use the Rectangle tool to draw a rectangle around the bottom of the candle. 05a79cecff
