We affirm the trial court's order denying the appellant's petition for writ of habeas corpus, without prejudice for the appellant to file a motion to correct sentence pursuant to rule 3.800, Florida Rules of Criminal Procedure, or a motion pursuant to rule 3.850, Florida Rules of Criminal Procedure. The appellant was sentenced to a fifteen-year

term of incarceration after pleading no contest to robbery with a deadly weapon, possession of a firearm by a convicted felon, and possession of a controlled substance. The appellant subsequently filed two motions, one pursuant to rule 3.850 and the other pursuant to rule 3.800, each of which was denied without prejudice for the appellant to file a second motion pursuant to rule 3.850. After the trial court ruled on the appellant's rule 3.850 motion, the appellant filed a petition for writ of habeas corpus in the trial court. The trial court denied the petition without conducting an evidentiary hearing. This appeal ensued. In his petition, the appellant argued that he was denied effective assistance of counsel because his counsel

failed to make certain motions or advise him of the possible negative impact of certain motions. He also argued that he did not understand the plea agreement and that his plea was involuntary because he was promised that a mandatory minimum sentence would not be imposed. In order for an ineffective assistance claim to be cognizable in the context of a rule 3.850 motion, "the claim must allege facts that, if proved at an evidentiary hearing, would establish a basis for relief." *State v. Hill*, 598 So.2d 246, 248 (Fla. 1992). The appellant's ineffective assistance allegations pertained solely to the time that was allowed for investigation. The appellant did not allege facts which, if proved at an evidentiary hearing, would

establish a basis for relief. In addition, the record demonstrates that the appellant entered an Alford[1] plea. This court has previously recognized that such pleas

The use of electrically conductive polymer dispersions in the manufacture of anti-static surfaces is well known in the art. The various requirements and properties of such conductive polymer dispersions are described in the paper "Electrically Conducting Polymer Dispersions" by D. W. van Krevelen and H. G. Gruber (Conference Proceedings--Electrically Conducting Polymers '87 (American Chemical Society, 1987), Vol. 1, pp. 24-32). The polymers utilized as anti-static

agents in the manufacture of anti-static surfaces must have several requirements. First, the anti-static polymer must provide a uniform coating on the surface. Secondly, the coating must be sufficiently conductive so as to develop an electric field to prevent accumulation of static charges. Furthermore, the conductive polymer should be sufficiently durable to resist erosion and flaking. Finally, the resistance of the coating should be low. Generally, a conductive polymer composition having adequate anti-static properties should possess a resistance of less than 10^{10} ohm-cm. The composition of electrically conductive polymers is known in the prior art. See, for example, U.S. Pat. No. 4,898,913. The use

of dispersions of electrically conductive polymers in the preparation of anti-static coatings is generally disclosed in U.S. Pat. No. 3,223,631. The use of electrically conductive polyanions is generally disclosed in U.S. Pat. No. 4,187,312. The disclosures of all the patents mentioned herein are incorporated herein by reference. Conductive polymer compositions containing small amounts of polyanionic functional groups are taught in U.S. Pat. No. 4,783,330, which describes conductive coating compositions containing polymers having a sufficient number of sulfonate groups and a charge density low enough to avoid the sensitizing effect caused by the sulfonate groups. The composition of this patent also requires a

crosslinking agent which is added in an amount of from about 0.1 to about 20 percent by weight of the polymer. U.S. Pat. No. 5,019,472 describes a conductive coating composition which can be applied to non-conducting surfaces and which is stable over time and which is capable of developing a low electrical resistance. The coating described in this patent comprises a conductive polymer, a crosslinking agent, and
